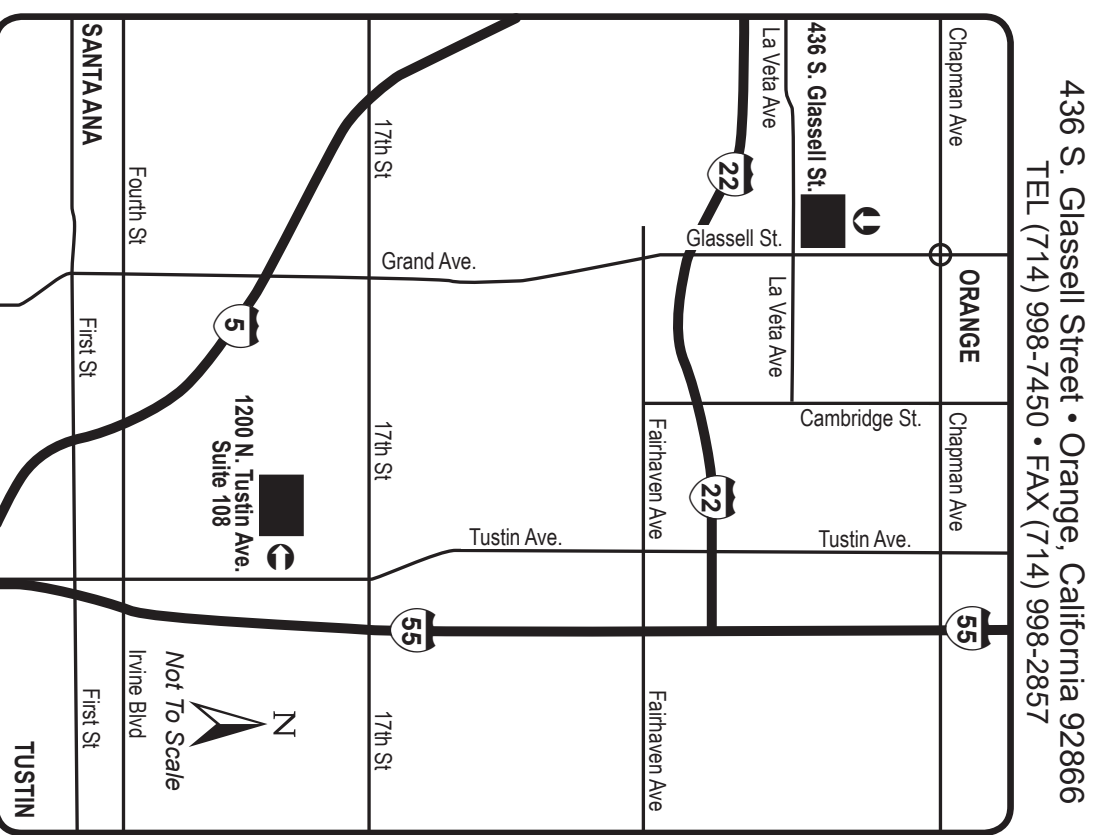

  - Wear loose-fitting clothing, short sleeves and tie on shoes.
  - Take medication as directed by Medical Doctor with a sip of water.
